## READ LABEL BEFORE USE

### WARNING

May cause an allergic skin reaction. May cause damage to the liver due to repeated ingestion. Hazardous to soil organisms.

Avoid contact with eyes and skin. Wash hands and face thoroughly after use. Do NOT eat, drink, or smoke while using. Wear disposable gloves while using.

### FIRST AID

This product is non-toxic to humans. Good hygiene should still be practiced. Wash any exposed skin with soap and water after use and before eating or smoking.

If swallowed do not induce vomiting and give one or two glasses of water. If feeling unwell, contact the National Poisons Centre (0800 764 766).

### USE RESTRICTIONS

DO NOT APPLY TO CROPS: WEED WEAPON PICLORAM GEL must NOT be used on plants intended to produce food for consumption by humans or animals.

This product must NOT be applied in areas that may be grazed by food-producing animals.

This product may only be applied using ground-based equipment.

Ensure treated leaves do not come in contact with desirable plants.

### DIRECTIONS FOR USE

WEED WEAPON PICLORAM GEL may be directly applied to leaves or cut stems using a brush-head applicator bottle or by direct painting using a stiff short-bristled brush. If applying using a brush, after brush transfer the amount of product to be used in one session to a separate container to avoid cross-contamination of remaining product.

- Apply gel within 15 seconds of cutting weed.
- Do not brush vigorously, avoid foaming.
- Although WEED WEAPON PICLORAM GEL may be applied at any time of the year, best applied when plants are actively growing in spring or autumn.
- Do NOT use if rain is expected within 12 hours.

Complete death of particularly large trees or shrubs may take several months. Repeat treatments will be necessary if regrowth occurs.

### WOODY SHRUBS AND WEEDS

- Cut down below the lowest green growth and immediately apply the gel.
- Apply a thick layer to cover the cut surface by either tipping the applicator bottle upside down or by painting with a brush.

### TREES (CUT STUMP)

**Including:** barberry, broom, buddleia, cotoneaster, elder, gorse, hawthorn, matagouri, pine, poplar, privet, sweet briar, tutu, wattle, willow, woolly nightshade, etc.

- Cut stem close to ground level (2-10 cm) and immediately apply gel to freshly cut surface. Ensure complete cover.
- Alternatively, for larger shrubs and trees with a trunk diameter greater than 15 cm, 4 or more evenly spaced cuts, about 2 cm deep, can be made with an axe or saw into the trunk near ground level. Apply the gel liberally into the cuts.

### IVY AND OTHER CREEPING WEEDS

**Including:** banana passionfruit, blue morning glory, greater bindweed, honeysuckle (Himalayan, Japanese), ivy (Cape, English, German, etc), jasmine, old man's beard, vines, etc.

- Cut the weed back as much as possible, approx. 2 - 10 above ground.
- Immediately apply a thick layer (3-5 mm) on the cut surface.

To minimise risks to any desirable tree the weed may be climbing, care should be taken to avoid the gel contacting the desirable tree. Damage may also occur to desirable plants should the gel be washed into the root zone, and alternative control methods should be considered.

### STORAGE

Store in original container tightly closed, away from foodstuffs, feed, and clothing.

Storage must be generally in accordance with the New Zealand Standard for the Management of Agrichemicals (NZ8409).

### CONTAINER DISPOSAL

Ensure container is completely empty. Triple rinse the empty container with water; dispose of washings by applying to an area of waste land. Recycle container where possible.

Do NOT burn.

### PRODUCT DISPOSAL

Ensure unwanted product is used by another operator strictly in accordance with label directions or dispose at an approved landfill or other approved facility.
